The Fund is a private investment vehicle for which Ayrton Capital LLC (the "Investment Manager") serves as the investment manager and Waqas Khatri serves as the managing member of the Investment Manager. The shares consist of (a) 3,817,523 ordinary shares plus (b) 1,790,00 PIPE warrants and 50,000 note principals, which were not exercisable as of February 1, 2021. As of February 10, 2021, the Adviser owned 0 ordinary shares, 1,790,000 PIPE warrants and 50,000 note principals.
